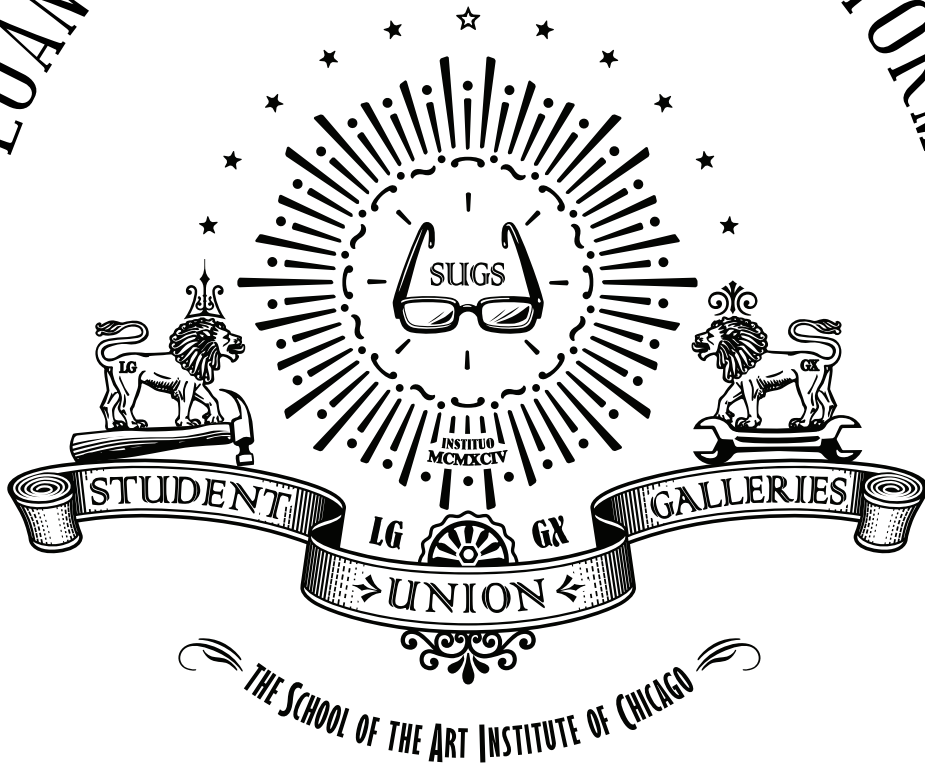

GENERAL CONDITIONS AND TERMS OF AGREEMENT

Insurance

The Student Union Galleries (SUGs) of the School of the Art Institute of Chicago (SAIC) does not insure artwork while on exhibition in Gallery X and the Lounge Gallery. It is the responsibility of the lender to provide insurance if the s/he so wishes.

Installation and Shipping

The lender is responsible for delivering the work to the exhibition site ready to install. The lender/artist will outline as applicable any specific installation requirements. The lender is responsible for the transportation of objects to and from the exhibition site.

Preservation and Exhibition

SUGs / SAIC will give the same care to the objects lent as is usual and customary of non-profit galleries in the Chicago area. SUGs / SAIC retains the right to determine when, if, how long, and where artwork borrowed will be displayed for any SUGs / SAIC exhibition. The lender agrees not to withdraw the loan during the period of this agreement without prior consent of SUGs / SAIC. SUGs / SAIC retains the right to relocate or remove any

artwork from an exhibition that may be in violation of the health and/or safety of viewers or participants, or that may be disruptive to the educational process. SUGs / SAIC release responsibility for the damage or loss of objects lent for the loan period stated.

Reproduction and Credit

Unless otherwise noted by the lender, SUGs / SAIC may photograph, telecast, or reproduce the object lent for educational, catalogue, and publicity purposes on condition that SUGs / SAIC applies the artist's copyright notice in accordance with United States copyright law. SUGs / SAIC will give credit to the lender as specified in this agreement in any instances of reproduction. Whether individual labels are provided for objects on exhibition is at the discretion of SUGs / SAIC.

Change in Ownership or Change of Address

It is the responsibility of the lender or lender's agent to notify SUGs / SAIC promptly in writing if there is a change in ownership of the object lent or if there is a change in identity or address of the lender. SUGs /

SAIC assumes no responsibility to search for a lender who cannot be reached at the address on record.

Return of Loans

SUGs / SAIC's right to return the loan shall accrue absolutely at the termination date of the loan. If the work lent is not claimed after three weeks from the date of termination of the exhibition, lender and artist hereby give all right, title, and interest in the work to SUGs / SAIC. At this time SUGs / SAIC may retain the work as a charitable gift absolute or dispose of the work in any way convenient for SUGs / SAIC.

Anti-Discrimination Law

SUGs SAIC strongly supports the exhibition of student work as an integral component of a fine arts education and does not discriminate on the basis of age, handicap, color, creed, national origin, race, sex or sexual preference in its exhibition practices.

Applicable Law

This agreement shall be constructed in accordance with the law of the State of Illinois.
